(ONAC) is a nonprofit Native asset-building coalition that collaborates with Native Nations and other partners to promote and establish Native-led and culturally compatible asset-building programs and initiatives in Native communities. ONAC and partners work together to create greater opportunities for self-determined economic success for tribal citizens.

### ONAC's Interrelated Asset-Building Programs (Continued)

#### Current Native-specific programs and initiatives include:

- Intermediary funder: Mini-grant program (supporting 20 Native VITA programs in 2023)
- National Native EITC/VITA Network
- Native Bank On ONAC
- Training and TA
- Resource guides: Investor education, remote financial education, and Native women entrepreneurs
- National research: Best practices for delivering Native asset-building programs (such as remotely-provided VITA in Native communities) and documentation of Native children's savings initiatives



### ONAC's Interrelated Asset-Building Programs

#### Current Native-specific programs and initiatives include:

- Native-specific financial education
- Financial coaching
- Children's Savings Account program
- Emergency Savings Account program
- Down payment assistance program
- Emergency cash assistance program
- Prevention of frauds and scams



## ONAC Awarding \$227,500 in Native VITA Funding

- The twenty grant awards represent the largest number of grant awards made during this tax season, in the country, by one grantor in support of Native VITA sites.
- ONAC was able to make these awards in 2023 with generous support from the Wells Fargo Foundation, Target Foundation, Kresge Foundation, and the Bank of America Charitable Foundation. Last year, also had support from Share Our Strength. Partnered with Code for America to co-host a training for VITA supporters to promote CTC outreach.
- These invitation-only Native VITA grants provide flexible funding for underserved Native VITA programs. ONAC offers a simple process for the grant applications and reporting.



   VITA site coordinators and advocates
- Share information, resources and opportunities
- Serve on Prosperity Now's Taxpayer Opportunity Network (TON) Steering Committee & provide a Native perspective when appropriate
- Sometimes invited to participate in National efforts to share the Native perspective



### **Unique Obstacles and Learned Best Practices for Outreach**

- One of the biggest obstacles facing Native communities now is the push for Facilitated Self Assistance (FSA) return filing when connectivity & related skills are lacking.
- As a best practice, outreach is best accomplished through trusted sources.



### Partnering as an Ally

- Be consistent in what you offer- don't start something, then disappear.
- Be respectful.
- Connect with Native VITA programs in your geographic area.
